## A LOOK AT HUMAN SEX TRAFFICKING

In March, 2013, Feminists Choosing Life hosted a 4-day series focusing on human sex trafficking as part of its participation in Season for Non-Violence. Our keynote speaker was Laura Lederer J.D. Laura is the former Senior Advisory on Trafficking in the Office of Global Affairs for the US Department of State and current President of Global Centurion (http://www.globalcenturion.org/), an organization which initiates and oversees research on the demand side of human trafficking. As part of her many contributions in the field of trafficking in persons, she founded and directed The Protection Project at Harvard University's John F. Kennedy School of Government in 1997. In 2000, she moved The Project to

Johns Hopkins University School of Advanced International Studies (SAIS). The Protection Project "focuses on promoting human rights around the world, fostering the growth of civil society, combating trafficking in persons, and advancing human rights education and the protection of minority groups". Laura is also adjunct professor of law at Georgetown Law Center, where she taught the first full course on international trafficking in persons offered at a law school.

FCL also hosted supporting speaker, Sue Thayer, former manager of a Planned Parenthood in Storm Lake, Iowa. After 17 years, Thayer began to question the motives

### From the editor's desk ...

#### From the editor's desk ...

The trial of late term abortionist Kermit Gosnell stunned the 25% of Americans who reported closely or somewhat closely following the horrific case. Arrested in Philadelphia in January 2011 on eight counts of suspected murder, Gosnell was found guilty of murdering three newborns by snipping their spinal cords with scissors after failed abortions and one count of involuntary manslaughter as a result of the death of patient Karnamaya Mongar. Mrs. Mongar died of cardiac arrest after

receiving a lethal dose of Demerol. Kermit Gosnell also faces more than 250 additional charges of crimes ranging from racketeering, performing abortions after the 24 week gestational limit, Theft by Deception and Corruption of a Minor. Gosnell faced receiving the death penalty for his crimes but abdicated his right to appeal in exchange for life in prison effectively choosing life for himself after callously taking the the lives of so many others.

The opinion of whether or not justice was served in this case varies. Some who believe Gosnell likely killed 100's of newborns in the fashion of which he was convicted, maintain that no amount of punishment can make up for the huge number of innocent lives lost at his hands. Others are thankful that his case raised awareness of what abortion really looks like and are satisfied in the knowledge that Gosnell will never live another free day. But rather than seeing the conviction of Kermit Gosnell as an end point, I am choosing to view it as the beginning of fresh scrutiny into what happens inside the abortion industry.

For example, as a result of the Gosnell trial, Rep. Trent Frank amended his D.C. Pain Capable Unborn Child Protect Act to apply nationwide (Unborn Child Protection Act H.R. 1797) and Senators Mike Lee and Ted Cruz have introduced a senate resolution demanding a review of public policies surrounding late term abortion. In Texas, the department of Health has launched a full investigation into abortionist Dr. Doug Karpen after Operation Rescue revealed details of Gosnell-like practices in his facility and in Maryland, abortionist Nicola I. Riley has finally had her medical license permanently revoked after she was found to have lied on her medical licensing application and guilty of unprofessional treatment of patients within her clinic.

Because of the horrors that were brought to light in the Gosnell trial, the pro-life community now has a renewed responsibility and opportunity to aggressively demand that our federal and state governments begin to hold themselves and abortionists responsible for what happens to women and the unborn behind closed clinic doors. Let this be our unifying goal and let's get to work.

## **FCL in Albany**

On April 15th, Feminists Choosing Life traveled to Albany to visit with state senators during the annual Legislative Advocacy Day. Twenty members and board members, working in pairs or small groups, sat down with senators and legislative aids to discuss FCL's opposition to the Reproductive Health Act and the abortion component within Governor Cuomo's Women's Equality Act. The conversations focused on New York State's 33% abortion rate (43% in NYC), the increased

chance of death for women during late term abortions and outrage that the governor's plan does not include any resources that enable women to carry their unexpected pregnancies to term. The responses from senators ranged from full support, to a "wait and see" attitude to unquestioning backing of the governor's plan.

During the visits, FCL also highlighted its support for S.1950: Provides that either a person or an unborn child at any gestational age can be the victim of assault. FCL members argued that the lack of any enforceable fetal homicide law in New

York is distinctly anti-woman and represents evidence that New York, through its laws has elevated a woman's right to choose abortion above her right to carry her child to term. Through the state's failure to recognize that an assault against a pregnant woman is very often an attempt to forcibly abort her, the state willingly overlooks her right to choose life for her baby.

While in Albany, several members and board members also met with three members of Governor's Cuomo's staff to express support for 9 out of the 10 points in The Women's Equality Act and disappointment that Governor Cuomo is holding real social improvements for women hostage to his radical abortion agenda by not removing the controversial abortion component so women and families could begin to immediately benefit from the remainder of the plan.

## SUMMARY OF BILLS

#### Governor Cuomo's Women's Equality Act (WEA)

On June 4th the Governor finally released the language for his Women's Equality Act. This plan has 10 points including an abortion component that will codify the 1973 abortion laws stemming from Roe v Wade. It will not however codify current, modern federal abortion laws.

Cuomo's abortion component disregards the Hyde Amendment that allows restrictions of Medicaid funding for abortions, Webster v. Reproductive Health Services in 1989 (which allowed states to recognize the unborn child as a human being and require ultrasound to test fetal viability), Planned Parenthood v. Casey in 1992 (which allowed parental consent and informed consent) and Gonzales v. Carhart in 2007 (which allowed the prohibition of partial-birth abortion and allowed limits on lateterm abortions). Cuomo seeks to establish the harsh scrutiny of Roe v. Wade as the law of New York and eliminate the common sense health regulations allowed by federal Supreme Court cases after Roe.

Essentially, the abortion component of the WEA will do the same to NY law as would the RHA. He merely uses different language to say the same thing.

As laid out, the Women's Equality Act has 10 points.

If passed, the WEA will:

- Protect a Woman's Freedom of Choice
- Achieve Pay Equity
- Stop Sexual Harassment in All Workplaces
- Allow for the Recovery of Attorneys' Fees in Employment and Credit and Lending Cases
- Strengthen Human Trafficking Laws
- End Family Status Discrimination
- Stop Source-of-Income Discrimination
- Stop Housing Discrimination for Victims of Domestic Violence
- Stop Pregnancy Discrimination Once and For All
- Protect Victims of Domestic Violence by Strengthening Order-of-Protection Laws

## SUMMARY OF BILLS

## Reproductive Health Act (RHA/S.438)

If passed, the RHA will:

- Make abortion a fundamental right much like the freedom of speech thus limiting legislative efforts to place common sense restrictions on the procedure such as a 24 hour wait period or parental notification.
- Will remove the physician mandate for the procedure prior to viability (defined as 24 weeks) and permit any licensed health care provider to perform abortions, making NY one of only 7 states without a physician mandate.
- Will allow abortion through all nine months of pregnancy through a broadly defined "health of the mother" exception.
- Will remove abortion terminology from the NYS penal code thus leaving the determination of whether or not to prosecute for a botched abortion to the discretion of the health department and state attorney general.

# S.1950: Provides that either a person or the unborn at any level of development can be the victim of assault

If passed, S.1950 will:

- Correct a significant loophole in NYS penal law that denies protection to pregnant women and certain children. Currently, an offender may not be held criminally responsible for the harm caused to a child unless that child has first been born alive. (Section 1, S.1950).
- Redefine homicide to mean conduct which causes the death of a person or an unborn child at any stage of gestation. (Section 4, S.1950).
- Affirm the right of a pregnant woman
  to carry her child to term and that
  perpetrators of crimes against pregnant women and their unborn
  children are held accountable for
  their crimes. NYS is one of only 13
  states without an enforceable fetal
  homicide law.
- Offer additional protection to women during pregnancy. Current statistics show that domestic abuse and violence against women increase at this time.
- Not apply to those seeking abortion nor will it change abortion laws.

of the organization when executives set monthly quotas for abortion sales in its clinics. She was finally forced out when she expressed concern over the safety of "Telemed" abortions and opposition to the practice of providing strong medications to women without first examining them in person. Since her departure from Planned Parenthood, she has been involved with 40 Days for Life campaigns and travels to pro-life events to share insider experiences working for Planned Parenthood. She recently appeared at the 2013 Students for Life of America conference where she and representatives of Alliance Defending Freedom addressed the topic of how to expose and defund Planned Parenthood in our communi-

The series of events began at the Little Theatre in downtown Rochester with a partial showing of the award winning documentary, Not My Life which takes an in-depth look at the problem of modern day slavery and human sex trafficking. Following the showing, Laura Lederer and the film's director, Academy Award nominee Robert Bilheimer, answered questions from the audience for almost an hour. Although the two speakers had not previously met, their knowledge and mutual passion for educating the public about this topic was evident and seeds for future collaborations were planted.

The series continued over the next two days with speaking engagements at Nazareth College and the Rochester Institute for Technology. Laura's presentation focused on addressing and reducing the demand for commercial sex as a way to eliminate sex trafficking and also highlighted preliminary interviews with victims that indicate approximately 117 out of 128 women experienced one or more abortions while being trafficked. Her initial hypothesis is the "noquestions asked" atmosphere within many abortion clinics, including Planned Parenthood, serves to facilitate trafficking by enabling traffickers to bring girls and women in for services without fear of discovery. Sue was able to

corroborate that clinic counselors often fail to sufficiently question young women concerning the circumstances of their visits and are not properly trained in identification of victims. Sue also indicated that questions intended to red flag women in crisis were gradually dropped from intake questionnaires at Storm Lake Planned Parenthood.

The campus visits to Nazareth were made possible through FCL board member and Nazareth professor, Mary Maher and through the co-sponsorship of the Feminine Alliance. The campus visit to RIT was possible through the co-sponsorship of the Women's and Gender Studies department at RIT.

The series concluded with a luncheon event held at the Susan B. Anthony House and Museum in honor of Women's History Month. The invitation-only event was attended by representatives of many community organizations including The Gandhi Institute, Alternatives for Battered Women, Feminine Alliance, Women's Care Center, Center for Missing & Exploited Children, Prevent Child Abuse NY, Forsaken Generation, Center for Youth, Rochester's Giving Circle, Bethany House, Temple Sinai and Church Women United. The luncheon was also attended by local college professors and members of law enforcement. The afternoon program included lunch and a lively panel discussion with Laura Lederer, Sue Thayer and Jennifer Wolfley of the Criminal Justice Department at RIT. Many different experiences with victims were discussed and plans for future collaboration between attending organizations planned.

Soon after this collaborative luncheon, these community leaders met and launched the Rochester Coalition against Human Trafficking. Hannah Murphy, Coordinator for Special Projects and Development now serves as the liaison between FCL and RCAHT. #### **February**

"I believe our foremothers would be the first to say that a woman who aborts is twice a victim-once from the act of unwanted conception and once from the physical trauma of abortion. The proposed legislation is not so much about women's health as it is about increasing the profits

of abortion clinics at the expense of unborn children and their mothers. Let's call it what it is: the Abortion Expansion Act"

#### Mary Krane Derr Pro-life Feminist Historian 1964-2012

Mary Krane Derr, co-author of ProLife Feminism, Yesterday and Today passed away unexpectedly while attending a poetry symposium in India. Mary was a pioneer in mining the pro-life spirit of American suffragist from the pages of women's history. A pacifist, who believed in using civil disobedience to solve conflicts, was the founder of All our Lives, a consistent life organization whose mission it was to build bridges between people of various perspectives based on points of common ground.

Mary was also involved with Feminists for Life of America until her resignation in 2007. She was an advocate of non-violent birth control, that which does not destroy a fertilized egg and had a desire to work more actively on pre-conception issues.

Mary lent her considerable skill and acute reading of history to the Susan B. Anthony Birthplace when she agreed to undertake a project that required her to read through each edition of SBA's "Revolution" newspaper and catalog articles which mentioned abortion, capital punishment, war and other consistent life ethic topics. The end result of her extensive research will be a kiosk at the museum that will allow visitors to search the "Revolution" using keywords.

Mary Krane Derr's important contribution to Women's History will not be forgotten.

FCL meets with Editorial Staff of the Democrat & Chronicle- FCL representatives Carol Crossed and Michelle Sterlace-Accorsi met with some members of the D&C editorial staff to express our concerns over the dangerous ramifications of the abortion component of Governor Cuomo's Women's Equality Act and to ask the newspaper to delay support for the bill until the exact language of the bill is released. On the day following the meeting two articles appears in the newspaper regarding the WEA, one an editorial asking the Governor to release the bill to allow for adequate public discourse. As of this writing, the Governor has yet to release his plan.

FCL board members Meg Smerbeck and Carol Crossed traveled to Hobart and William Smith College to attend the Round Robin Invitational, a competitive debate tournament including Chinese Human Rights advocate Cheng Guangcheng. Carol and Meg shared FCL's involvement in the sunglass

campaign initiated by Women's Rights without Frontiers. Chen was aware of the campaign and attributed his freedom in part to those efforts in the United States.

May

Kathy Peters and Colleen Spellecy, FCL co-liaisons for Seneca Falls, organized the "Birthplace to Birthplace" bus trip that offered a tour beginning in Seneca Falls, the birthplace of Women's Suffrage to the Birthplace of Susan B. Anthony in Adams, MA. This fun day included luxury transportation to Adams where participants toured the SBABM, the Quaker Meeting House where the Anthony's attended weekly meeting and St. Stanislaus Church, a nationally recognized cathedral built in 1905.

FCL participated with Feminists Choosing Life Action, Inc. in an opposition rally at Senator Ted O'Brien's

Rochester office. He is a co-sponsor of the Reproductive Health Act and has promised support for the governor's Women's Equality Act with its radical abortion component. There were more than 100 people present to express disappointment in O'Brien's support. Several days later, eight WEA supporters hosted a counter rally at the same office.

FCL attorney, Kathleen Scanlon was the key responder to Erika Bachiachi at a lecture in the Gospel of Life series at Fordham University. The two discussed trends in abortion law and sexual economics and considered goals and opportunities for collaboration among feminists. Ms. Scanlon used Feminists Choosing Life vs. the Empire State Stem Cell Committee and NY Health Department as a demonstration of egg purchasing as a point of commonality between pro-choice and pro-life feminists.
